Call to Order: President Baarck called the meeting to order at 6:32pm

Agenda: The agenda was discussed with additions. Motion to approve by Davidek, supported by Conzelmann. Motion passed.

Minutes: The minutes of the December meeting were discussed. Changes: Bamberg on page 2 name is missing the g. Motion to approve by Conzelmann, supported by Palmer. Motion passed.

Treasurer report: Welchli reviewed reports. Piesko questioned trap and skeet inventory costs. Schultz will look back at years past, can also check with Hartman when he returns. Piesko questioned youth account losses and other losses. How long can we keep taking losses? Need to look at generating more cash. Wanless stated he had some idea. Motion to approve Treasurer report by McClure, supported by Bennetts. The motion passed.

Smoker Report: Welchli reported – 201 in attendance, many youth guests.

Scholarship: Baarck reported on the Frankenmuth Community Foundation. 5% distribution each year. Turn over \$20,000 to the Foundation. Northern Trust would invest for us – we would still have control. He spoke with John Webb – we could do a hybrid fund, advantage we would be

listed with their groups that can generate more funds. It is something to think about. John can come out and give more specifics. Have him come in March.
